By order of the Chief Judge, on August 27, 2020, the District of Columbia Court of Appeals adjusted its operations to address concerns regarding the Coronavirus (COVID-19) through November 30, 2020. The court plans to issue another order regarding operations subsequent to November 30, 2020, which will further address court operations. All cases scheduled for oral argument for the month of December will be heard by a panel of judges via videoconference.
